Cookies Policy

The private company under the name "NEW ERA P.C.", with distinctive title "MONASTY", established in Thessaloniki, 45 Vasileos Irakliou Street, PC 54623, tel.: +302310 274545, e-mail: info@monastyhotel.com, intends hereby to inform the users of the website regarding the Cookies that are being used and the collected information during their browsing.

What are cookies?

Cookies are small text files, which a website stores to your computer or your mobile device, when you visit that website. This way, the website remembers your actions and your preferences for a period, so that you don't need to enter your preferences every time you visit the website or browse its pages. Cookies help you browse to a more friendly and easy-to-use environment. Cookies don't collect information individually, but when read by a server via a web browser, they can give information in order to offer a more friendly service to the user.

Which are the types of cookies? What types does the website www.monastyhotel.com use?

Cookies are divided to persistent cookies and session cookies.

- Persistent cookies are files stored on your computer and stay there,
 when you close the browser, unless you delete them.
- Session cookies contain information used to your browser's current browsing and they are deleted when your browsing is over or/and after closing the browser.

Moreover, cookies can be installed by the website's provider which the user visits (first party Cookies) or from other third parties through the website's provider of the (third party Cookies). Finally, Cookies are divided to strictly necessary cookies for the correct and seamless operation of the website and optional Cookies.

More specifically, according to article 4 paragraph 5 of Law 3471/2006, as it is replaced by the article 170 of Law 4070/2012 and in force, the use of Cookies is allowed only upon user's consent after he/she has been clearly and

extensively informed. Exceptionally, consent is not required regarding Cookies whose sole purpose is the transmission of a communication via an electronic communications network or Cookies that are necessary for the provision of an information society service, which the user or the subscriber has expressly requested.

What cookies are used by our website and what information is collected?

The website www.monastyhotel.com uses cookies for various purposes depending on their function:

• Necessary/ Essential Cookies. These Cookies are essential for the efficient operation of the website. They store information about the maintenance of the user's session, the user's/visitor's preferences (language etc.) as well as to provide improved services. Without these Cookies, we cannot provide efficient and safe operation of our website, therefore your consent about their use is not required.

Analytical / Statistics cookies or performance cookies. These cookies are used in terms of internal research about the ways to improve the services provided to all our users. Cookies just rate the way you interact with our website as an anonymous user (collected data do not personally identify you) or the effectiveness of an advertising campaign. Also, these data are not disclosed to third parties and are not used for any other purpose. According to no. Γ/ΕΞ/1525 recommendation of the Hellenic Data Protection Authority, the use of traces of third parties, such as Google Analytics service for the purpose of web analytics, can take place only after consent given by the website user.

You have the discretion to withdraw you consent whenever you want or to

object to the use of cookies to your computer or device, to control and/or

delete the cookies.

If you don't want the cookies, you can choose every time, through the

specific emerging banner on the website, the settings that you prefer

for your computer: COOKIE SETTINGS - DENY ALL - ALLOW ALL

COOKIES.

You can delete the cookies from the computer or device you use,

whenever you want, from your browser's settings. That way, you can

withdraw your consent about the use of cookies to your computer or

your device.

You can also set the browser you use in a way that it can warn you

about the use of cookies in specific services of the websites or so that

it does not allow the acceptance of cookie usage in any case.
